



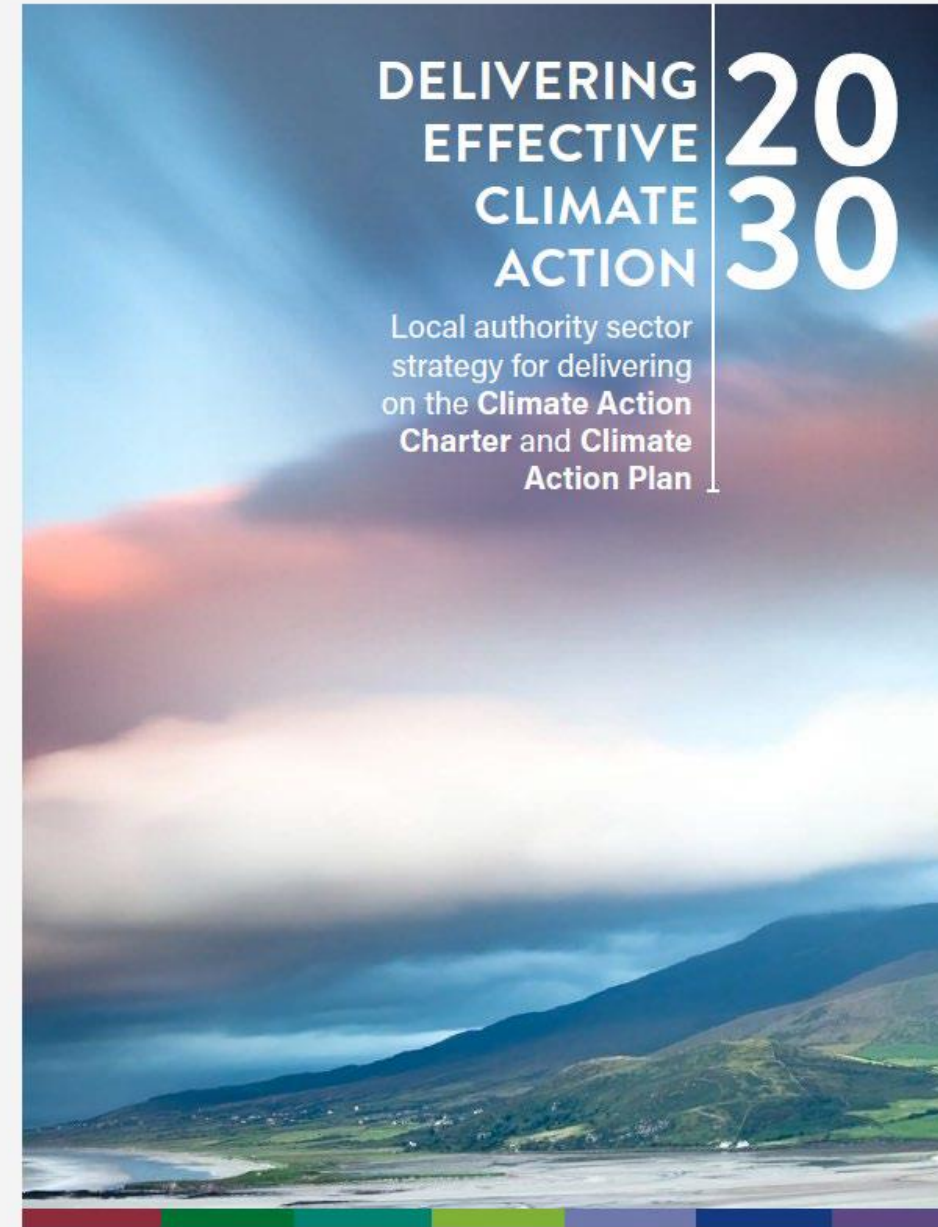

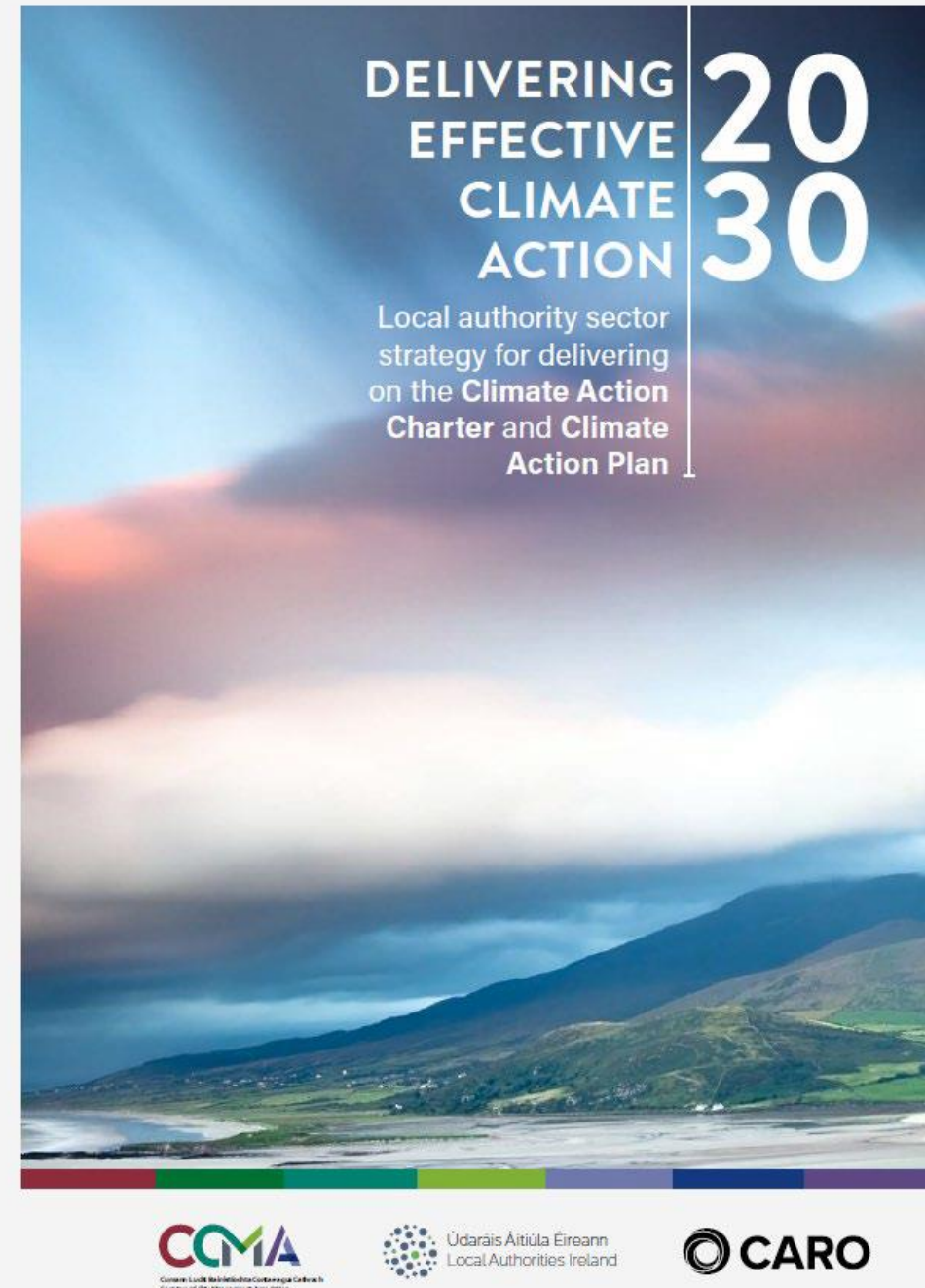
One of the most important and urgent areas being addressed currently by Ireland's City and County Councils is that of climate change.

Also, in late 2020 we completed our sector's Climate Action Strategy DECA 2030.

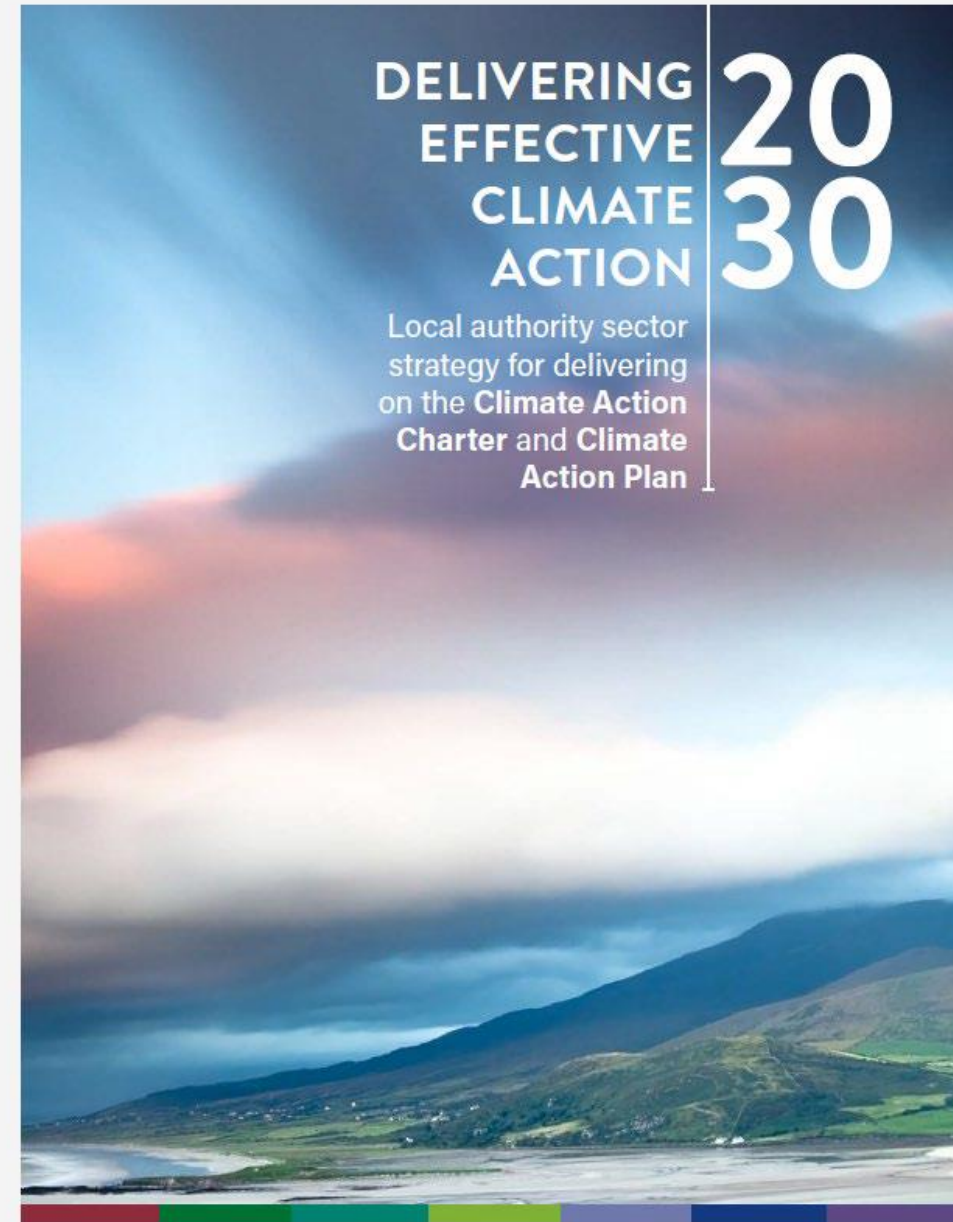

- maximise our leadership role.

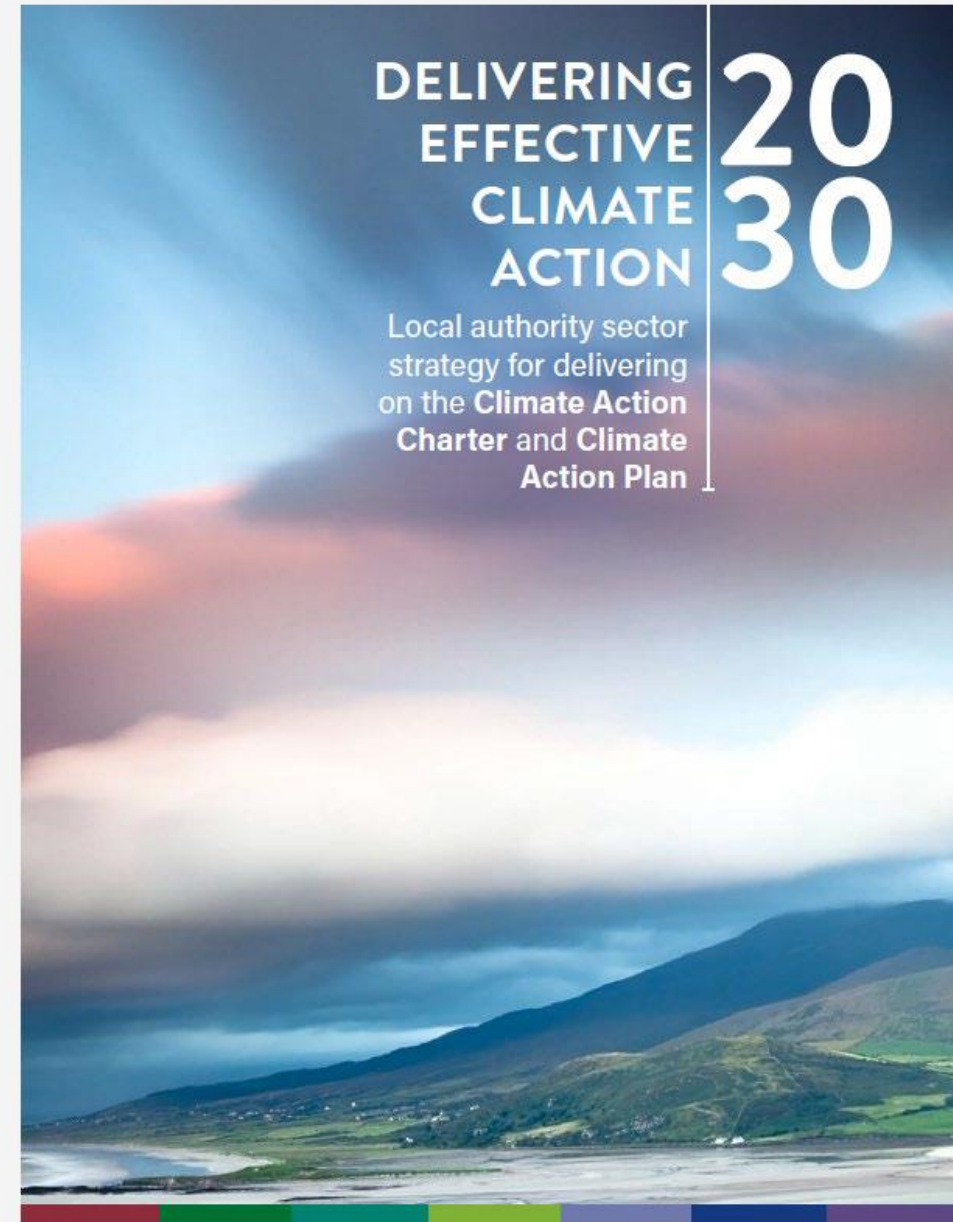

We are uniquely positioned to lead locally, to ensure a coordinated local response to the global challenge of climate change bringing our communities, businesses and staff along with us.

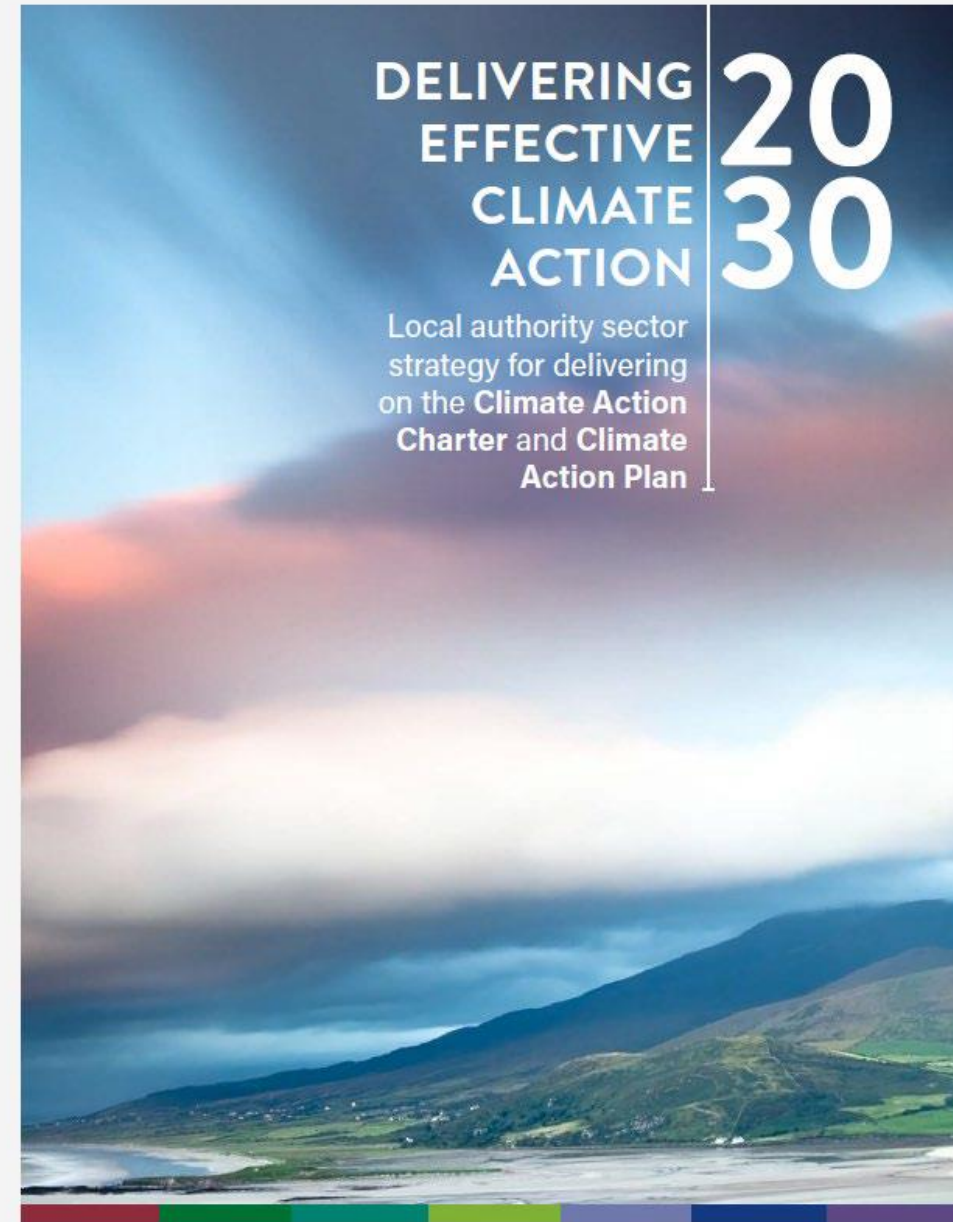

with a mission ***to deliver transformative change and measurable climate action across our cities and counties and within our own organisations, through leadership, example and mobilising action at a local level.***



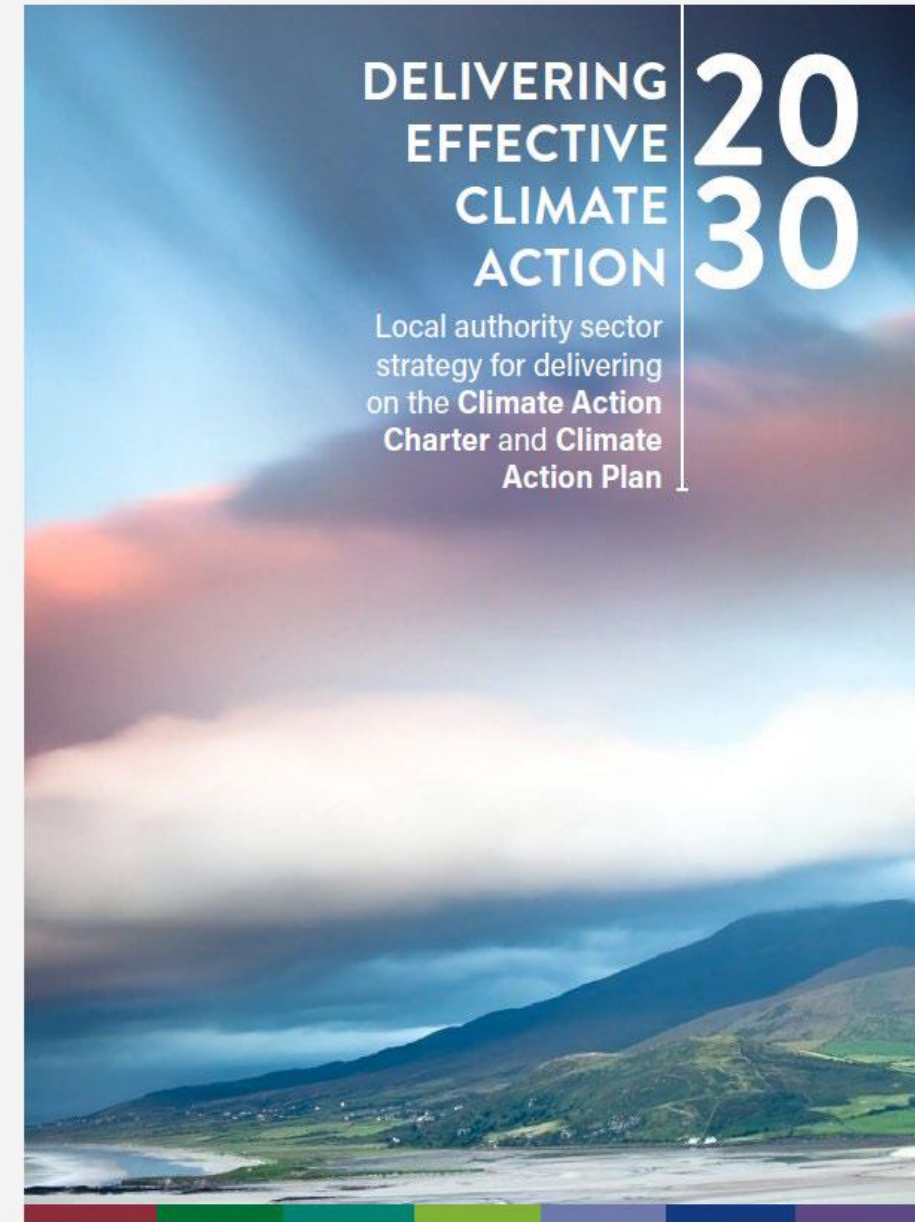

We have identified the resource requirements and structures that would assist local government to deliver on the goals and objectives outlined in DECA 2030.





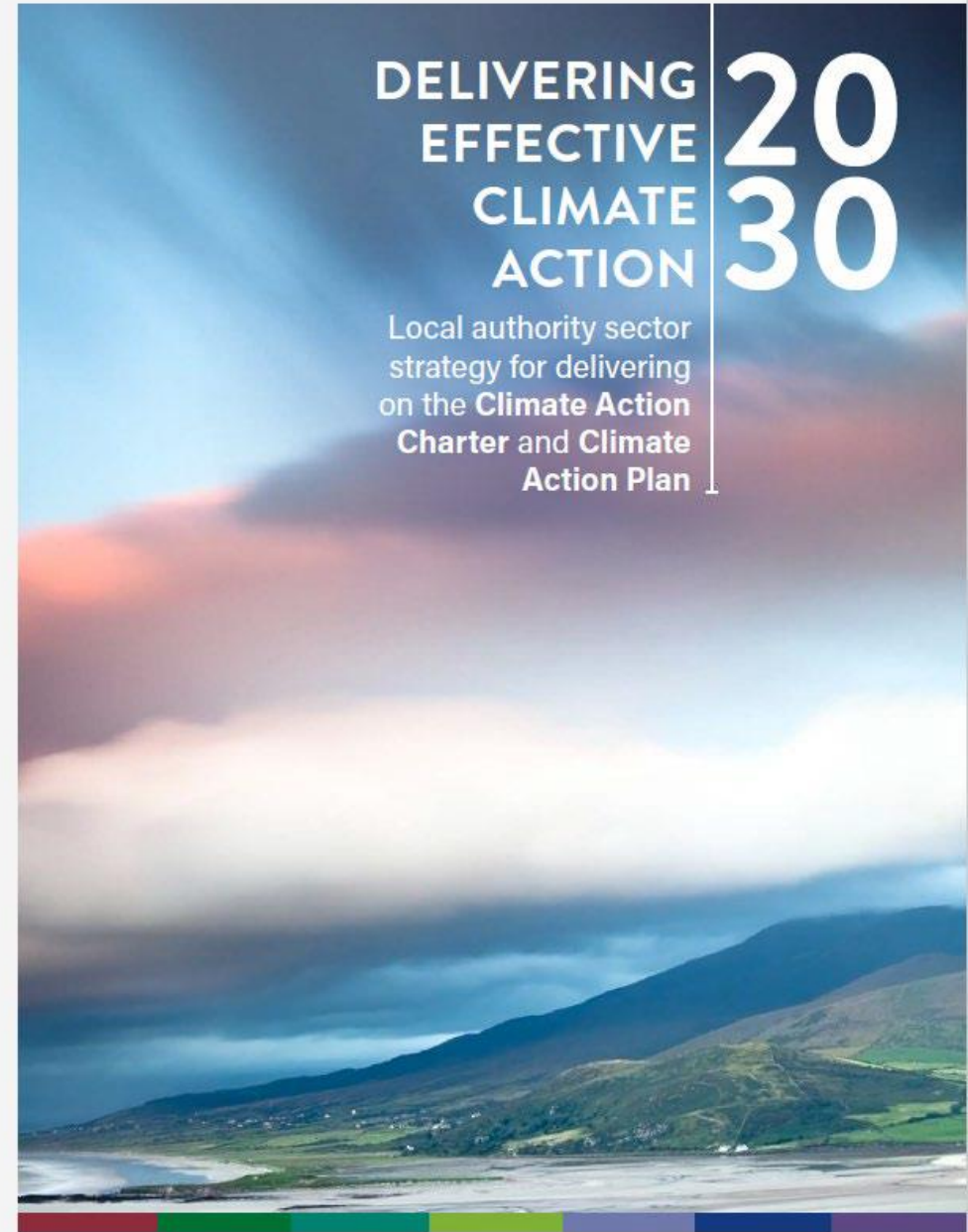
